Upon motion of the United States and for good cause appearing, Attachment A, to wit: Department of Veterans Affairs Police Revised Collateral Forfeiture Schedule, is hereby adopted with immediate effect. The 2023 schedule reflects the state codes, title of offenses, and collateral amounts to be enforced by U.S. Department of Veterans Affairs Police without the concurrence of the U.S. Attorney's Office, which were traditionally referenced from the Utah Uniform Fine/Bail Schedule and will hereafter be applied pursuant to 18 U.S.C. § 13, also known as the Assimilative Crimes Act. All other state crimes not listed shall be deferred to the US Attorney's Office for concurrence before enforcement under the Assimilative Crimes Act.
