





### HISTORY OF SEALED AND RESTRICTED ACCESS

Public Access Presumption: Historically, court records and proceedings have been open to the public to ensure transparency and trust in the judicial system. This presumption of openness is a fundamental principle but has been tempered by the need to protect certain information.

Sealed Documents: Over time, courts have recognized the need to seal documents or entire cases to protect the identity of someone wrongly accused of a crime, preserve the integrity of criminal investigations, and avoid exposing national security matters. Sealed documents are typically not accessible to the public, and even their existence might not be apparent on public dockets.





#### WHY THE CHANGE?

- •To maintain the public's right to access cases, documents, and docket entries, but allow counsel greater access to filings with protected information, the court is launching a Pilot Program for criminal cases.
- Under this program, certain documents, and docket entries will have a presumptive restricted access level, determining who can electronically access the information.



#### NOT THE FIRST TO DO IT

- We consulted with other districts to understand their approaches to restricted access.
- Our model is a modified version of the Colorado framework, particularly in its tiered access levels.





- Begins December 1, 2024
- Will run for 1 year
- Criminal cases only
- Tiered access levels
- Initiated by General Order 24-004
  - Some local rules will be suspended in whole or in part during the pilot program.

### WHAT WILL BE ACCESSIBLE?

There are 3 levels of restriction, separate from "SEALED," under this Pilot Program that give certain parties remote electronic access:



Restricted level 1: provides access to the parties (which includes all defendants in a multi-defendant case) and the court (which includes probation);



**Restricted level 2:** limits access to the filing party, counsel for the affected defendant(s), the government, and the court;



Restricted level 3: limits access to the filing party and the court.



Sealed: limits access to court and probation employees.



### PUBLIC DOCKETS


- DOCKET ENTRIES WITH RESTRICTION LEVELS 1, 2, AND MOST 3 WILL BE VISIBLE ON A PUBLIC DOCKET.
- The docket text will reflect the entry level.
- Public will <u>not</u> be able to view the document if they click on the hyperlinked docket number.

### WHAT WILL HAPPEN IF YOU DON'T HAVE ACCESS?

- Depends on the level of restriction.
  - An entire docket entry may be skipped, or
  - Attorneys who are not counsel of record will not be able to view the document.
  - This message will appear when someone without access clicks the hyperlinked document number.





### US ATTORNEY ACCESS

- DOCKET ENTRIES WITH RESTRICTION LEVELS 1, 2, AND MOST 3 WILL BE VISIBLE ON A DOCKET.
- The AUSA of record will be able to open the documents by clicking the hyperlinked docket number for Levels 1 & 2.
- The AUSA of record will only be able to open Level 3 documents if they are the filer of the document.
- A Notice of Electronic Filing will be sent to the AUSA of record for Levels 1 and 2, and most 3 filings.



### DEFENSE COUNSEL ACCESS

- DOCKET ENTRIES WITH RESTRICTION LEVELS 1, 2, AND MOST 3 WILL BE VISIBLE ON A DOCKET FOR THE APPLICABLE DEFENDANTS.
- Public dockets for all defendants will show the docket entries for all co-defendants. However, defense counsel of record will only be able to open documents that relate to their defendant.
- Defense counsel of record will only be able to open Level 3 documents if they are the filer of the document.
- A Notice of Electronic Filing will be sent to all defense counsel for Levels 1 and 2, and most 3 filings.



# NOT ALL LEVEL 3 ENTRIES WILL APPEAR ON A DOCKET

- Some Level 3 events will be restricted to only the applicable or filing party.
- New filing events have been created to make it clear when that will occur.
- These new events will have a **(Restricted)** notation next to them on the list of Available Events. For example:
  - Motion types
    - Re-appoint Counsel (Restricted)
    - In Camera Review (Restricted)
    - Ex Parte Defense Authorization (Restricted), requesting:
      - Excess Compensation
      - Issue Subpoena
      - Jail Visit
      - Appoint Expert
      - Miscellenaeous
  - Subpoena Under DUCrimR 17-2 (Restricted)
  - Return of Service Defense Subpoena (Restricted)



# NOT ALL LEVEL 3 ENTRIES WILL APPEAR ON A DOCKET


• Example: Defendant files a pro se motion for re-appointment of counsel.

# PROBATION FILINGS - VIOLATION PETITIONS


- Petitions for supervision violations will continue to be processed under the current practice.
  - Summons requested Petition=public access, Summons=Restricted Level 2
     Access.
  - Warrant requested Petition and Warrant both Sealed.
- Petitions and warrants will be <u>unsealed</u> upon the filing of the returned warrant (may be redacted similar to summons practice).

• **WARNING**: In multi-defendant cases, **DO NOT** select the main case number unless the filing applies to all defendants in a case.









 When filing documents with restrictions, if prompted, make sure you select only the parties on the case who should have access to the document.

Select parties on the case who should have access to this docket entry and document.





Defense and USAO counsel will continue to have the ability to file motions or documents under seal in <u>unsealed</u> cases.

Defense and USAO counsel will continue to be restricted from accessing sealed cases and sealed filings in unsealed cases.

No Notice of Electronic Filing will be sent for sealed entries. A certificate of service/mailing certificate must be attached to sealed filings, if sent to the other parties.

Numbers will continue to be skipped on the docket protecting these entries.




# A WORD ABOUT COOPERATORS



- Documents discussing cooperation <u>MUST</u>
  be filed using the <u>SEALED MOTION</u> OR
  <u>SEALED ENTRY-DOCUMENT</u> EVENTS.
- **EXCEPTION**: If filing a "Motion to Reduce Sentence USSC Amendment" that discusses cooperation\*, you must file it using that event and choose the sealing option.

  Should this ENTRY be sealed?



\*May also be sealed if sensitive information like medical records attached.



### COURT AND PROBATION USERS

 Court and Probation staff will continue to have access to all entries and documents for every defendant, including sealed and "court only" entries.




A MOTION MUST BE FILED TO ADD OR CHANGE A RESTRICTION LEVEL

The motion will be unrestricted and public.

The motion must be supported by a separately filed, sealed memorandum.

The sealed memorandum must explain the basis for adding or changing the restriction level.



#### Materials will be posted on the court's website):

- Finalized and effective General Order explaining the different levels.
- A list of documents and their respective restriction levels.
- Step-by-step instruction and tip sheets.
- Video demonstrations how to file:
  - Restricted Motions
  - Motion and Memorandum to Change Restriction Level.
