IN THE MATTER OF EMPTYING :
AND REFILLING THE MASTER : **ORDER**
JURY WHEEL :

It appearing to the Court:

That the Amended Plan of the United States District Court for the District of Utah for the Random Selection of Grand and Petit Jurors, hereinafter "Plan," adopted by this Court pursuant to the provisions of the Jury Selection and Service Act of 1968 (Public Law 90-274, Sections 1861 through 1874, Title 28, United States Code), provides that the master jury wheel is to be emptied and refilled in each odd-numbered year; and

That the Plan further provides for the use of automated systems for the random selection of names of grand and petit jurors from the electronic data base of voter registration lists of all of the counties that comprise the District of Utah; and that the number of registered voters selected from each county's list for the master jury wheel reflects the same proportion that each county's registered voters comprise of registered voters of all counties in the District of Utah; and,

That the business of the Court requires that the names of thirty five thousand (35,000) prospective jurors be placed in the master jury wheel when said wheel is emptied and refilled; and

That the schedule attached hereto and incorporated herein prepared by the Clerk of Court shows the total number of names of registered voters in each county in the District of Utah, and the number of names of prospective jurors to be selected at random from the electronic data base of all county voter registration lists, to be placed in the master jury wheel for the District of Utah to ensure that the registered voters in each county will be proportionally represented in said master jury wheel. Therefore, and good cause appearing,

IT IS HEREBY ORDERED that pursuant to the Plan, the Clerk of Court shall select at random a total of thirty five thousand (35,000) names from the electronic data base of voter registration lists of the counties in the District of Utah.


IT IS FURTHER ORDERED that the number of names to be selected from each county's voter registration list for the master jury wheel reflects the same proportion that each county's registered voters comprise of the registered voters of all counties in the District of Utah.

IT IS FURTHER ORDERED that in making the random selection of names of prospective jurors, the Clerk shall utilize an automated random selection application that independently generates a new random number each time it selects a name from the electronic data base of each county's list of registered voters for purposes of refilling the Court's master wheel. In establishing the range of numbers within which a random number will be selected for each county, the range will include the number one (1) through the number that represents the total number of registered voters for that county, i.e., the total number in the database for that county. The random number generated will be based on a computer algorithm that will allow for an equal chance of selection for each person within the database. As prospective jurors are selected to fill the master jury wheel, each registered voter in the database will continue to have an equal chance of being selected from the remaining pool of registered voters in the database.

IT IS FURTHER ORDERED that the Clerk of Court, upon completion of the random selection of the thirty five thousand (35,000) names of prospective jurors in the manner above ordered, shall report to the Chief Judge the date upon which the Clerk, pursuant to this order, will purge the master jury wheel of any remaining non-deferred names, then refill the same by placing therein the names selected pursuant to this Order.

In compliance with the provisions of the **Amended Plan of the United States District Court for the District of Utah for the Random Selection of Grand and Petit Jurors**, adopted by this Court, and pursuant to the provisions of the Jury Selection and Service Act of 1968, Sections 1861 through 1874, Title 28, United States Code, the Clerk of Court reports and recommends the following:

1. That, on the basis of past and current requirements for prospective jurors, the grand and petit juror needs of the Court for the period of January 1, 2012 through December 31, 2013 will require the drawing of approximately thirty five thousand (35,000) names from the Court's master wheel/database of prospective jurors;
2. That, in order to respond to the juror requirements of the Court over the specified period and to foster efficiency in the juror qualification and summoning process, the names will be drawn in groups of three thousand seven hundred fifty (3,750) at the following times: November 2011, February 2012, May 2012, August 2012, November 2012, February 2013, May 2013 and August 2013. The Court's master wheel/database contains the names of thirty-five thousand (35,000) prospective jurors, and each group of three thousand seven hundred fifty (3,750) names will be drawn randomly from that database. The names will be drawn randomly by the court's automated selection system as specified in the Court's Amended Plan for the Random Selection of Grand and Petit Jurors.
3. That public notice of the drawing from the Court's master wheel/database be given by posting a copy of this Report and Recommendation on the public bulletin board in the main corridor of the courthouse at 350 South Main Street, Salt Lake City, Utah. An electronic copy of the Report and Recommendation will be also available on the court website.

4. That the Clerk of Court, using the names that have been drawn from the Court's master wheel/database as specified above, will address and otherwise prepare the official summons/qualification questionnaire forms and, upon completion, deliver the forms to the U.S. Postal Service for mailing via first-class mail to the prospective jurors.


