

UACT PROGRAM RULES

1. You must be truthful in your comments and answers and must affirmatively disclose all non-compliance with pretrial release conditions and program rule violations.
2. You must come to court when you are scheduled to attend, which will likely be every week. If you do not come to court, a bench warrant may be issued. If you do not come to court regularly, you may be removed from UACT.
3. If you ever have questions about whether or not you need to come to court, contact the UACT Probation Officer in advance. Do not make a unilateral decision about your attendance.
4. You must wear court appropriate clothing when you come to court. This means no immodest clothing, tank tops, clothing that is ripped, dirty, or has inappropriate messages or pictures on it.
5. You must contact the UACT Probation Officer to provide updates at least once a week, or as often as the Probation Officer directs, and be truthful in your comments and answers.
6. You must follow the directions of the UACT Probation Officer, all of the conditions of your pretrial release, and the orders of the UACT Judicial Officers.
7. To complete UACT successfully, you must complete all of the requirements of your program plan and maintain sobriety for at least six (6) months prior to graduation.
8. You must go to treatment, work in treatment, and make progress in treatment. You must also pay co-payments for treatment if ordered to do so.
9. You cannot use alcohol or drugs while you are in the program. You must submit to tests for alcohol and drugs whenever the UACT Probation Officer orders you to do so. Any medicines prescribed for you must be shown to the UACT Probation Officer. If you are prescribed a narcotic while in UACT, you will not advance in the program until you are testing negative, even if that means you are in the program longer than 12 or 24 months.
10. If you do not submit to drug/alcohol testing when your probation officer orders you to do so, you will be given a sanction unless the UACT Probation Officer excused you from testing before you miss it.

11. If you use any kind of device or try to beat a drug or alcohol test in any way, you will get a serious sanction and could be removed from the program. Dilute samples will be sanctioned.

12. If you commit new criminal conduct (even if not arrested or charged) you may be removed from UACT, even if you are not convicted of the new crime.

13. You can be removed from the program for any threats or violence – even if you do not get charged with a crime.

14. If you abscond from the program (fail to come to court and/or stop having contact with the UACT Probation Officer) you may be removed from the program.

15. After you have been accepted into the program, if you fail to make your first UACT court appearance you may be removed from the program.

16. To graduate from UACT, you must follow all employment and/or educational/vocational requirements, unless you have been excused for a medical condition or disability by a doctor.

17. You must tell the UACT Probation Officer about any illness or condition that you are seeing a doctor about, including any chronic pain, any attention deficit disorder, and any addiction to alcohol or drugs. If you have an addiction to /alcohol or drugs, you must tell your doctor.

18. You are encouraged to bring family members and supportive friends with you to court, but if you bring small children to court, you must also bring another adult who can watch them while you are talking with the UACT Team. This adult must also be responsible to take the children home and care for them if necessary.
