GENERAL ORDER

No. 18-007

In fulfillment of the Court's obligation to promote judicial economy and the orderly working of the judiciary, the following case-management procedures are established to address the large number of cases alleging violation of copyright laws by use of BitTorrent to illegally download movies ("BitTorrent Protocol cases") that have been or will be filed in this court. The objective of this order is to streamline procedures, avoid duplication of work, combine similar hearings, avoid inconsistent decisions, and promote judicial economy.

To achieve this goal, all currently pending BitTorrent Protocol cases will be transferred immediately to Judge David Nuffer, and any existing referral to a magistrate judge will be vacated.¹ Until otherwise ordered, all BitTorrent Protocol cases that are filed after the date of this General Order shall be directly assigned to Judge Nuffer.

Accordingly, IT IS HEREBY ORDERED that the following cases be transferred to Judge David Nuffer and that any existing referral to a magistrate judge be vacated:

¹ One case (2:17cv16 TC) will not be transferred at this time, due to the pending settlement and dismissal of one defendant. The case may be transferred at a later date after the resolution of that pending settlement.
