

INFORMATION FOR TRAVELERS

You have been summoned to appear as a juror for the United States District Court for the District of Utah. We are the Federal Court and have jurisdiction over the entire state of Utah. You are summoned to appear in the Federal Courthouse in Salt Lake City, Utah.

If the **one-way** distance between your residence and the courthouse exceeds 80 miles, you may choose to arrive the day before you are to report. If you do, your meal and hotel costs will be reimbursed to you. The current government hotel rate is \$127.00. **You must submit a receipt for your hotel to be reimbursed for lodging costs; if you stay with a friend or relative, or choose to drive back and forth, your daily travel reimbursement will be limited to \$56.00 for meals and incidentals.** Your round-trip mileage will also be reimbursed at the current federal government rate.

While the court does not endorse particular hotels, there are several hotels located within walking distance to the courthouse. These hotels are listed below and have been vetted to ensure that they comply with Covid-19 health protocols. Please also be sure to mention you are on Federal Jury Duty and request the government rate when you make your reservation. If you have any trouble making reservations or need assistance please contact the jury office as soon as possible at 801-524-6285. Please pack accordingly, the typical trial last from two to five days.
